### 2. Objectives and Legal Bases

The following personal data will be processed by the RHA:

- For the purpose of membership administration, the RHA collects and processes those personal data of the members that are retrieved in this application for membership. These data will be supplemented with Club-related data. The legal basis is specified in Art. 6 Para. 1 lit. b) GDPR.
- For the purpose of contribution administration the RHA will work with the banking data of those members using cashless transactions. In case of SEPA Direct Debit Scheme or bank transfers, this includes the name of the account holder, name of the bank, BIC, IBAN, mandate reference, date of the mandate and the year of the first direct debit. The legal basis is specified in Art. 6 Para. 1 lit. b) GDPR.
- Access to all processed personal data is limited to the Management Board and the Data Protection Officer (DPO) Rolf B. Krukenberg. Data Transfer is in required frame purpose-bound limited to the involved banks.

### 3. Maximum Storage Time

- All data required for membership administration will be deleted 10 years after termination of the membership.
- All data required for contribution administration will be deleted according to tax law regulations in Germany, currently after 10 years.

### 4. Data Protection Rights (Data Subjects Rights)

Each person concerned can defeat his rights (data subject rights) vis-à-vis the responsible, using E-Mail, Mail or a provided Form. Even telephone inquiries are possible. However, telephone inquiries are only accepted, but not answered by telephone. The responsible selects the medium (Mail, E-Mail, or other media) and sends the answer to the request to the person concerned. Answers to requests of data subject rights are free of charge. Excessive exercises of the rights can result in a fee. Answers will be send within the legal deadline of one month. In exceptional cases, the timeframe for answers can be prolonged (i.e., high number of requests or high complexity of the request). The extension of the timeframe must be justified.

For a better overview, the data subject rights are listed briefly below:
